International Attendees

Invitation Letters

Our policy is that invitation letters can be issued only to speakers, presenters, committee members, IEEE members or persons known by the organizing committee. In addition, registration fees must be paid in full before the letter is provided. Letters will only be sent by US Postal Mail or fax and only to the individual registered for the conference.

Payment

Payment must accompany all registration forms and can be made by credit card (MasterCard, VISA, American Express, Diners Club), check, or wire transfer. Checks or money orders must be in U.S. funds, drawn on U.S. banks, and payable to the IEEE Computer Society. No registrations will be accepted over the phone. **Forms received without actual payment WILL NOT be processed.**

On-Site Registration

On-site registrants will pay late registration fees. Credit cards (MasterCard, VISA, American Express, Diners Club) are the preferred form of payment. All checks must be in US funds drawn on US banks. Wire transfers will not be accepted.

Cancellations and Substitutions

Cancellations and substitutions are allowed.
